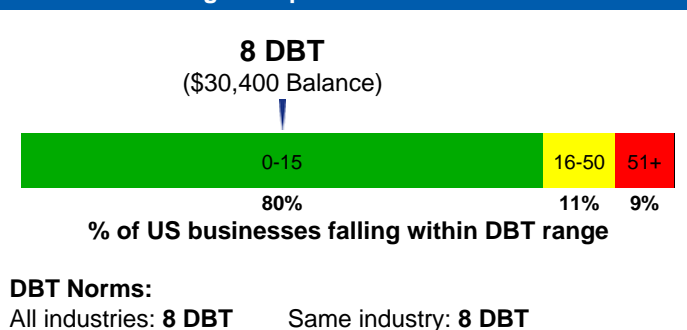

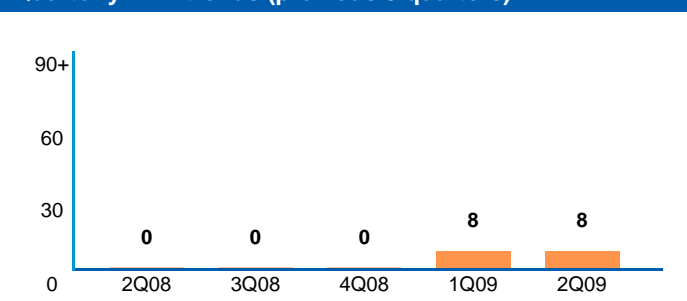
Current DBT range compared to all industries*

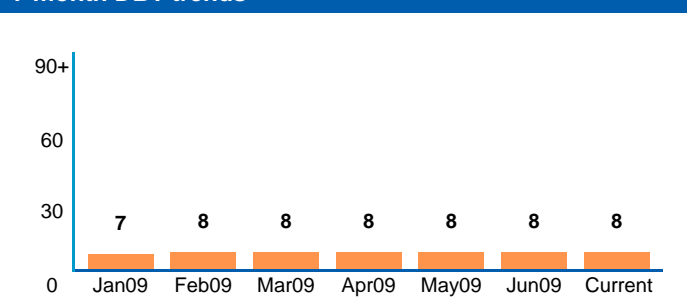
Quarterly DBT trends (previous 5 quarters)
